Dear Artist,

Enclosed is an entry form for and information about the Noreascon 4 Art Show and Print Shop, to be held in the 3rd Floor Ballroom of the Hynes Convention Center in Boston, Massachusetts over the 2004 Labor Day Weekend. Since we expect Noreascon 4 to be attended by at least 5,000 fans, sales should be good. Our goal is to have a well-balanced display of artists from all over North America and from around the world.

The Art Show will be about the same size as recent North American Worldcon art shows. We will have over 350 4-foot-by-6-foot panels for flat art, plus three to four dozen 6-foot-by-30-inch tables for 3-D works. There will also be a Print Shop. Art will be sold by written bid, with voice auctions for pieces which accumulate sufficient bids. All pieces will remain in the show until at least 5 PM on Sunday, September 5, 2004. Multiple copies of reproductions may be sold for a fixed price in the Print Shop.

The attached pages describe the rules for the Art Show. **Please read them carefully**, and write to us promptly if you have any questions. The Art Show rules try to be fair to both you and the art buyers; as with any compromise, this may not satisfy everyone.

When you reserve space in the Art Show, you must pay the amount shown in the chart on the entry form. Noreascon 4 will charge a hanging fee but will charge no commissions on sales.

We hope to hear from you, and we look forward to seeing your work in Boston next Labor Day. Don't delay, or the show may be filled up!
